Partnerships with the Private Sector—CalOES and CAL FIRE

During the first few days after a disaster, government resources are focused on saving the most critically injured and restoring life-saving infrastructure. Private industry, working in conjunction with government, can help address the needs of individuals/families and businesses that may be unprepared to sustain themselves during the first few days after a major disaster.

Businesses can do much to prepare for the impact of the many hazards they may face in today's world including natural hazards such as floods, earthquakes and widespread serious illness such as the H1N1 flu virus pandemic. Human-caused hazards include accidents, acts of violence and acts of terrorism. Examples of technology-related hazards are the failure or malfunction of systems, equipment or software.
